## COURSE DESCRIPTION

After Reunification of Germany in 1990 Berlin became the national centre of politics. The course will explore significant features of the German political system, it will highlight the dominant place of the German parliament, the role of political parties and the function of the federal government. The class will address main political actors, interests, and cleavages.

We will discuss and learn about: Why is Germany a Federal State? What are the reasons for its administrative set-up? What makes German domestic politics so difficult? What is the German outlook on European Union integration? What about Germany's approach to international climate change policies? The class work will be supplemented by an excursion to the Bundestag, lower chamber of the national parliament, it will include visits and talks to elected members of parliament and their staff, and it will present insights into the work of party foundations.

## COURSE OBJECTIVES AND LEARNING OUTCOMES

The objective of this Bachelor-level course is to equip students with an in-depth understanding of the German political system, providing them with profound insights into the democratic and federal foundation of German domestic and European politics. The class will provide students with theoretical and empirical knowledge about the presented topics, and it will enable to develop academic skills and personal competences of political analysis. By the end of the course participants will be able to:

- Identify the specific features of the political-administrative set-up of Germany
- Comprehend the peculiarities of contemporary German democracy
- Provide an overview of political actors, important political issues, and fields of action
- Describe the functioning of the German parliamentary, governmental, and party system
- Analyze and reflect on the process of political deliberation and decision making
- Communicate and discuss theoretical positions, empirical facts, and observations.

### Workload and assignments

In order to be granted 6 ECTS, participants will be asked to

- actively attend all sessions (a minimum of 75% attendance is required for classroom and online sessions)

  - an oral in-class presentation, duration 10-15 minutes
  - a written report on one of the excursions / visits / talks, length three to five standard pages DIN A4, Times New Roman, 12 pt., 1,5 line spacing
  - a written research paper on a topic chosen from the seminar schedule, length five to eight standard pages DIN A4, Times New Roman, 12 pt., 1,5 line spacing

Failure to fulfil one of the mentioned components results in failure of the class.

### Assessment Components

The final grade will be composed of the above-mentioned assignments.

The calculation of the final grade will be based on the formula: Oral presentation 25% + written report on excursion 25% + written research paper 50%.

# COURSE SCHEDULE

## **Week 1: Wednesday 7 September**

### **INTRODUCTION**

The first session, being an introduction to the course, will present a topical overview, will familiarize the participants with the needed political science vocabulary and terminology, will acquaint with the reading material and the required academic literature, will point at additional audio-visual material, will explain the individual work load, the written and oral assignments and, finally, will show the complete learning schedule consisting of classroom work with lectures, presentations and discussions being supplemented by several external visits and excursions.

## **Week 2: Wednesday 14 September**

### **POLITICAL HISTORY – Cold War and Division of Germany after 1945, the Fall of the Berlin Wall and German Reunification 1989-1990**

The second session will deal with Germany's post-WWII history, it will show and explain the political developments during Cold-War confrontation resulting in the division and partition of Germany. The class will learn about the reasons for overcoming the destructive logic of political conflict in Central/Eastern Europe providing the chance for breaking-down the Berlin wall, for opening-up the inner-German border and finally paving the way to German reunification in 1990.

## **Week 3: Wednesday 21 September**

### **POLITY – The Federal Republic of Germany: Constitutional order and administrative set-up**

The third session will acquaint the participant with the basic constitutional provisions of the political order of Germany; students will learn about the core of democratic ideas and liberal principles forming the legal-political framework of the Federal Republic of Germany. The class will be instructed about key features of the current political-administrative set-up of Germany, it will learn the geographic, territorial, the economic, demographic, and cultural composition of the contemporary German Nation-state.

## **Week 4: Wednesday 28 September**

### **POLITY - *The Bundestag: Legal and political Role and Functions***

The fourth session is devoted to the study of the *Bundestag*, the German Parliament. The class will learn about the principal legislative role and the political functions of this lower chamber of the German legislature. Students will become knowledgeable about the Parliament's structure and organization, about the procedural order of law making; they will learn about *Bundestag's* current party (factional) structure, about the three-party ruling majority in parliament, which has started a long-ranging reform agenda. Attention is also given to the opposition parties in the Bundestag, ranging from far left over the center to far right / populist positions.

## **Week 5: Wednesday 5 October**

### **POLITY – *The Bundesrat (Second Chamber of the German Parliament): Role, Functions, Structure; The Federal President: Role and Functions***

The fifth session introduces into the Bundesrat (Federal Council), Germany's second legislative body, being composed of representatives of the 16 German "Bundesländer" which form the Federal Republic. This chamber plays a vital, indispensable, sometimes decisive role in the national law-making process. In a second step the class will learn about the constitutional role and the political functions of the German Federal President, being the Head of the State, representing Germany on the international stage and holding crucial prerogatives of power.

## **Week 6: Wednesday 12 October**

### **POLITY - *The Federal Government: Role, Functions, Structure***

The sixth session will study the structure, the ministerial composition, and the political functions of the German federal government; participants will learn both about the established tradition and the difficulties of running coalition governments in Germany. The class will receive an up-to-date picture of the current federal government, its ambitious reform agenda alongside with its shared goals and objectives; at the same time the seminar will also be informed about involved party cleavages as well as hidden or open conflict lines between the coalition partners.

### **Week 7: Wednesday 19 October**

#### **POLITICS - "Bundestag" Parliamentary elections: election law, campaigns, recent results**

The seventh session will touch upon the German electoral law, it will scrutinize its peculiar construction combining traits of majoritarian and proportional political representation, reflecting in a specific way the lessons learned from the tragic failure of the German pre-WWII parliamentary democracy at the end of the fragile "Weimar Republic". The class will learn about socio-economic and cultural cleavages in the German electorate, it will get insights into campaigning and see a picture of the political results of the Federal elections September 2021.

### **Week 8: Wednesday 26 October**

#### **POLITICS - Excursion and visit to the German Parliament "*The Bundestag*"**

The eighth session is entirely devoted to the visit of "The Bundestag". The class will make an excursion to the German parliament residing in the former building of the "Reichstag" in the very center of Berlin. Depending on the schedule of parliamentary work there will be either a chance of making a guided tour through the entire building, learning both about its history and its contemporary modernist reconstruction; or there will be the opportunity to pay a visit to the plenary hall and to watch a debate session from the elevated visitor tribunes.

### **Week 9: Wednesday 2 November**

#### **POLITICS - Political Parties in Germany – Historical roots, ideologies, performance**

The ninth session analyses the German political party system. Students will learn about the pre-history of the in Germany nowadays influential political parties, the class will dwell on socially and historically grounded cleavages between the political camps of Conservatism, Liberalism, Socialism, Feminism and Ecological Activism; and the seminar will be instructed about the current electoral performance of the major political parties in Germany.

**Week 10: Wednesday 9 November****POLITICS - Excursion and visit to party foundations / NGOs**

The tenth session is destined for visiting political party foundations – and / or NGO headquarters. Participants will have the chance of getting first-hand information on their political objectives, ideological orientation, guiding principles, support and funding, social and educational activities in society-at-large. Depending on the availability within the work schedule of party foundations the class may pay a visit to foundations either of Christian Democrats, Social Democrats, Liberals (Free Democrats), or the Green-Ecological Party.

**Week 11: Wednesday 16 November****POLITICS – Encounter and discussion with members of parliament, politicians, and advisors**

The eleventh session will once more take place inside the German parliament, this time for a meeting and a discussion in the offices of parliamentarians, their staff, and advisors. During this visit participants will get first-hand information about how the daily work of parliamentary communication, interest representation, and political decision making is organized. Students are encouraged to prepare their own points of interest for a stimulating exchange of opinions.

**Week 12: Wednesday 23 November****POLICIES - Environmental and climate change policies**

The twelfth session deals with analysis of a policy field located in the very center of the German societal and political agenda. The pressing issues of global warming, of rapid climate change, of biological habitat and natural environment preservation do result in heated debates about appropriate measures within the political, social, and economic domains. German politics at the national, regional, and local levels increasingly responds to these new challenges. Students will learn about the specific approaches and solutions German politicians come forward with.

**Week 13: Wednesday 30 November****POLICIES - Migration- and refugee policies**

The thirteenth session will focus on German migration and refugee policies vis-à-vis the challenges of forced and voluntary migration in- and outside Europe. The class will get to know of the political debates and civil society activities in Germany aimed at finding remedies and solutions for the mounting, albeit diverse migration problems, ranging from deliberate, voluntary migration into the German labor market to the humane treatment of refugees and asylum-seekers. The Seminar will be based on recent research literature and on topical news coverage.



## **Week 14: Wednesday 7 December**

### **POLICIES - German approaches to EU integration and international affairs**

The fourteenth session is devoted to the European and the foreign policy dimensions of Germany's state-political orientations. Germany, the most populous and economically most powerful member-country of the European Union is destined to play a decisive role in the process of European-Integration. Students will learn about German approaches in the controversies about the supra-national objective of an "*ever closer Union*" versus the inter-governmental model of "*a Europe consisting of nation-states*". A discussion about Germany's role in international conflict resolution and joint peace keeping missions will conclude the seminar.
