

SEEING LIKE A CITY/ SEEING THE CITY THROUGH

Welcome to the RN37 conference in Berlin!

It is an honor to write these few words as a warm welcome to you all. We are happy that you made your way to us and thank the RN37 Board for enabling this to happen and for their support in organizing. We also thank the Sektion Stadt- und Regionalsoziologie of the German Society of Sociology (DGS) for their collaboration. With Liza Weinstein, Susanne Frank and Tommaso Vitale, we have secured three fabulous keynote speakers that will help us frame the concerns of the conference. In the first keynote Liza Weinstein will talk about the case of evictions and housing struggles in Indian cities, seeing the Indian city through time, globally and historically. Our second keynote with Susanne Frank will take us to the level of local urban transformation and seeing the city through neighbors and emotions of nostalgia or melancholia. In our final keynote, Tommaso Vitale approaches the city from the edge of marginalization, reflecting on the conference theme through his extensive work on Roma in European cities. With the journal sub\urban, we have found a wonderful collaboration in a special lecture by Marco Aparicio, who will bring into discussion the activist ambitions of urban scholarship. The theme of the conference started from the idea that urban citizenship implies a fragmentation of claims that affects

The theme of the conference started from the idea that urban citizenship implies a fragmentation of claims that affects rights to the city as universal, all-inclusive ideals. Noting a trend towards a diversification of interests, a weakening and separation of movements, and competition about resources rather than more solidarities within groups working as collectives on the pathway to a livable and more just city, we see a need for extended conversations. With the destructive war of Russia against Ukraine, even questions of rights to live in

peace are violated closer to Berlin than has been the case for a long time: in a European urban conference, we may need to signify that, after when we designed the initial call, the language of 'rights' to the city has taken on entirely different connotations a few hours drive from here. Two special panels in the conference have been designed to discuss the urban futures at risk, and urban scholarship at risk in zones of war and oppression.

What has not changed in all this is that different modes of governance always require categorizations on various scales. And any categorization is likely to conflict with locally embedded practices, knowledges, and ways of seeing and doing things. Seeing this especially on and from the urban margins, we aimed to put a broad, inclusive program together that addresses this main topic in a wide variety. You will find an extremely dense program with many fascinating paper sessions and special events. I wish you inspiring days with lively conversation and a lot of learning and listening.

OPENING PLENARY LECTURE (KEYNOTE 1)

Seeing the City through Time: Historicizing Urban Sociology through the case of India's "World Class City" Evictions

Wednesday 13:30 – 15:30

Despite Manuel Castells' widely cited claim that "cities are the products of history," urban sociologists have tended to look more to the future than the past to explain the social and political conditions of cities and their residents. Emphasizing transformative processes and emergent developments, urban sociologists have generally paid less attention to the entrenched politics and longstanding institutions that also shape space and politics in cities. The primary aim of this talk is to push back on this tendency and consider how the study of urban social and political change can be deepened by centering temporal concerns and historical methods. Emphasizing both how we "see the city through time" and what is gained when we do, this talk draws from research on recent rounds of residential evictions in India's major cities that tended to be explained through economic liberalization and emergent capitalist formations. Resisting these totalizing explanations, the talk emphasizes how housing rights in contemporary Indian cities are not only being remade by the transformative processes, but are also shaped by the critical events, settlement histories, protest cycles that have unfolded over several decades. Drawing from this case study, the talk suggests ways urban sociologists can be more sensitive to the historical production of cities while researching the urban present.

Talja Blokland (Chair)

Professor of Urban and Regional Sociology at Humboldt-University Berlin

Professor Talja Blokland is an urban sociologist who has worked at Yale University, the University of Manchester and various Dutch universities. Since 2009, she has held the chair of Urban and Regional Sociology at Humboldt-Universität zu Berlin. Her publications include Urban Bonds (Polity 2003), Creating the Unequal City (edited with Giustozzi/Krüger/Schilling, Ashgate 2016), Community as Urban Practice (Polity 2017), and various articles on race and ethnicity in the city, poor neighbourhoods, urban violence, gentrification, urban middle classes and neighbourhood relations and everyday interactions.



Liza Weinstein (Speaker)

Department Chair; Associate Professor of Sociology at the Sociology & Anthropology Department, Northeastern University

Liza Weinstein is an Associate Professor of Sociology at Northeastern University in Boston. Her research focuses on the politics of urban development and contested housing rights in cities in India and in comparative perspective. She is the author of The Durable Slum: Dharavi and the Right to Stay Put in Globalizing Mumbai (University of Minnesota Press, 2014), and is currently completing a book on the shifting politics of housing insecurity and anti-eviction activism in urban India since the 1970s. She is currently one of the editors of the International Journal of Urban and Regional Research (IJURR).

"Neighborhood Melancholy" and "Neighborhood Nostalgia": Two Moods and Modes of Dealing with Painful Neighborhood Change

In my contribution, I introduce "neighborhood melancholy" and "neighborhood nostalgia" as two concepts to capture the moods and modes with which working class residents respond to structural change that becomes painfully concrete for them in and through the transformation of their neighborhood. The underlying research project combines several established or emerging research fields from an urban sociological perspective: Sociology of Loss, Urban Emotion Studies, Psychoanalytic Geographies, Deindustrialisation Studies, Neighborhood Studies, and Urban Planning.

The concepts are developed from comparative empirical research in two former working class neighborhoods in the Ruhr cities of Dortmund and Essen, which underwent rapid decline after the end of heavy industry. In both quarters, many long-standing residents strongly relate their experiences of individual and collective loss (of status, recognition, community, belonging...) to the influx of new social groups into the area to whom they lost their neighborhood-defining role. For many of the old-established residents, this confirms or reinforces the widespread feeling of having been pushed from the center to the margins of society.

Despite all these similarities, however, there are also key differences. These concern the way in which the old-established residents perceive the neighborhood change. My central thesis is that in Dortmund-Hoerde, a melancholic mode of viewing and experiencing neighborhood change dominates, while in Essen-Altenessen, a nostalgic mode prevails. I understand melancholy and nostalgia as "structures of feeling" (R. Williams), each of which refers to specific ways of articulating emotions with which one reacts to painful loss, e.g. grief, sadness, fear, annoyance, anger, bitterness, etc. The emotions at stake in both concepts are thus very similar. What varies, however, is their "formation" or "structuring".

I attribute the differences in emotional structuring to the importance of the respective neighborhood for the development of the city as a whole, which in turn is reflected in the social status of the undesired new neighbors. Hoerde is an area that has massively been upgraded as part of Dortmund's overall urban development strategy. There, the newcomers belong to a higher class than the old-established; the concern is therefore about being

marginalized through 'up-classing'. In contrast, the newcomers to Altenessen are low-status, often very poor immigrant groups whose increasing presence is seen as evidence of the further decline of the neighborhood. The old-established workers therefore feel marginalized through 'under-classing'.

Finally, I show that "neighborhood melancholy" and "neighborhood nostalgia" each also give rise to particular ways of coping with social and structural change.



Gabriele Manella (Chair)

University of Bologna

Gabriele Manella is Associate Professor in Urban and Environmental Sociology at the University of Bologna. His recent research interests are focused on land use policies in some metropolitan areas, energy poverty and energy citizenship in some urban neighborhoods, and slow tourism trends in the Italian marginal areas. He is the Board Coordinator for the RN37 – Urban Sociology of ESA and Secretary of the Mediterranean Association for the Sociology of Tourism.



Susanne Frank (Speaker)

School of Spatial Planning at TU Dortmund University

Susanne Frank is a Professor of Urban and Regional Sociology at the School of Spatial Planning at TU Dortmund University. She studied at the University of Freiburg and also received her PhD there. Further stations were Bauhaus University Weimar and Humboldt-University Berlin.

Her research has focused on the sociology of housing and settlement (especially suburbanization and gentrification), neighborhood change, and the role of nature in urban development. In recent times, her fascination and attention have increasingly focused on how the digitalization of all areas of life is calling into question everything we previously thought to know about city life and urban social relations.

CLOSING PLENARY LECTURE (KEYNOTE 3)

Contentious Sights. Seeing the (European) cities through Roma lens

No urban or rural area in the entire European continent does not see a long-term presence of people treated as gypsies or who self-describe as belonging to a Roma group. In most of the cases, they are stigmatised and segregated, but not always and not in the same way. Lot of research has been dedicated to problems of Roma exclusion and segregation, sometimes of their upward social mobility too. But this knowledge is usually presented in a format where it can hardly be incorporated into urban thinking. The exceptions are related to its random treatment among others of poor immigration, which hardly lends itself to capturing the whole of the Roma issue, and to the point of poverty and homelessness, which again only partially covers the Roma issue and indeed poorly relates to the great entrepreneurial and financial capacities of many Roma. What do we understand about cities by empirically and partially studying the modes of Roma embeddedness? We derive indications to

enrich a theory of urbanisation very much based on the tension between micro-sociological and macro-sociological forces with an analytical centrality of the meso dimension related to collective action, and especially with indications related to the functioning of the interaction between the three levels of reality. This could lead to the rejection of answers all based on the determinism of the (macro) categorisation that structures collective action and interaction between individuals. Without thereby denying the strength of this descending form of segmented and subordinated integration. This may imply assuming the hardness and difficulty of the challenge of public interventions and forms of collective action that are anti-discriminatory and attentive to individual rights.

The keynote will mainly present the main findings of a qualitative survey on the problems of access to adequate housing for people who identify themselves as Roma (the project R-Home). The survey is based on 128 qualitative in-depth interviews and 10 focus groups with Roma living in difficult, deprived and segregated contexts as well as with policy makers, administrators, and activists, both locally and at regional and national levels. We studied in France the metropolitan area of Paris, in Italy the metropolitan area of Milan, in Spain the metropolitan area of Barcelona, in Hungary the cities of Gyöngyös and Miskolc, in Romania two municipalities in the historical region of Transylvania, in Singeorgiu de Mures (Mures County) and in Sfântu Gheorghe (Covasna County), in the Orko neighbourhood.



Marta Smagacz-Poziemska (Chair)

Associate professor at the Institute of Sociology of the Jagiellonian University

Marta Smagacz-Poziemska is an associate professor at the Institute of Sociology of the Jagiellonian University. Her main research interests involve urban sociology, sociology of local communities, social inequalities, and urban sustainability. Cur-

rently, she is a PI of the project "Normality under uncertainty. Praxeological approach in research on the (re)production of 'normal' urban life" [National Science Centre in Poland] (2022-26). She published and edited books and articles on urban changes, neighbourhoods, and local participation. 2017-21 she was a Coordinator of the Research Network 37 (Urban Sociology) of the European Sociology Association; since 2022 a member of the Executive Committee of Polish Sociological Association.



Tommaso Vitale (Speaker)

Sciences Po, CEE & Urban School

Tommaso Vitale (Ph.D in Sociology, MA in Political Science, both at the State University of Milan), researcher at the Center for European Studies and Comparative Politics, where he co-coordinates with V. Guiraudon the research program "Cities, borders and (im)mobility" and "Cities are back in town". He is Dean of Sciences Po Urban School. In the past

he has been co-editor of the peer-review Journal PArtecipazione e COnflitto. The Open Journal of Sociopolitical Studies and scientific director of the master program "Governing the Large Metropolis" (Sciences Po Urban School). His empirical research has been organised around a main theoretical framework: a Weberian sociology, attentive to structural contexts of opportunities at different scales, to explore the relation between social and spatial factors influencing forms of collective action. This framework irrigates his three research projects: 1) Roma agency, integration and upward social mobility; 2) the political sociology of associations and NGOs in urban societies; 3) the impact of urban social and spatial structure on electoral behaviour.

Septic academy: Fragments of an activist human rights pedagogy

The relationship between activism and academia, between analytical rigour and engagement, has always been a contentious one. The appearance of scientific objectivity has sought to construct an aseptic rationality which, as is well known, has been responsible for legitimising and ratifying the dominant voices, the great indisputable and unquestioned academic and political consensuses. This has been and continues to be the role of the respectable, recognised academy, the one that aspires to "excellence". This phenomenon is widespread, but it is most virulent in the "core" disciplines, which in the field of social sciences are fundamentally law and economics. For this reason, and referring to the world of law, the experiences and learning offered by critical pedagogies linked to activism in defence of human rights are particularly valuable. In them, academic rigour (theoretical, methodological) is understood as the best ally of militant commitment. This rigour is built from and in favour

of situated experiences, subjective needs in movement, and seeks to nurture dialogue between theoretical, methodological, dogmatic and moral or political factors.



Lisa Vollmer (Chair)

Bauhaus-Universität Weimar

Lisa Vollmer is researcher and lecturer at Bauhaus-Universität Weimar. Her research focuses on housing, social movements and governance. She is part of the editorial team of "sub\urban. zeitschrift für kritische stadtforschung".



Marco Aparicio (Speaker)

Universitat de Girona

Marco Aparicio is Professor of Constitutional Law at Universitat de Girona and holds the UNESCO Chair on Sustainable Human Development. He is also a human rights activist and the president of Observatori DESC, a human rights centre that concentrates its efforts on dismantling the devalued perception of Economic, Social, Cultural and Environmental Rights.

Estate Regeneration and Its Discontents. Public Housing, Place and Inequality in London, Policy Press

Public housing estates are disappearing from London's skyline in the name of regeneration, while new mixed-tenure developments are arising in their place. This richly illustrated book provides a vivid interdisciplinary account of the controversial urban policy of demolition and rebuilding amid London's housing crisis and the polarisation between the city's have-nots and have-lots. Drawing on extensive fieldwork and interviews with over 180 residents living in some of the capital's most deprived areas, Watt shows the dramatic ways that estate regeneration is reshaping London, fuelling socio-spatial inequalities via state-led gentrification. Foregrounding resident experiences and perspectives both before and during regeneration, he examines class, place belonging, home and neighbourhood, and argues that the endless regeneration process results in degeneration, displacement and fragmented communities.

Paul Watt is professor in Urban Studies at Birkbeck College, University of London. Maxime Felder is a visiting fellow at the Erasmus University Rotterdam. Jan Üblacker is professor for neighborhood development, esp. housing in neighborhoods at the EBZ Business School (FH).

The Commodification Gap. Gentrification and Public Policy in London, Berlin and St. Petersburg, Wiley 2022

The Commodification Gap provides an insightful institutionalist perspective on the field of gentrification studies. The book explores the relationship between the operation of gentrification and the institutions underpinning – but also influencing and restricting – it in three neighborhoods in London, Berlin and St. Petersburg. Matthias Bernt demonstrates how different institutional arrangements have resulted in the facilitation, deceleration or alteration of gentrification across time and place.

The book is based on empirical studies conducted in Great Britain, Germany and Russia and contains one of the first-ever

English language discussions of gentrification in Germany and Russia. It begins with an examination of the limits of the widely established "rent-gap" theory and proposes the novel concept of the "commodification gap." It then moves on to explore how different institutional contexts in the UK, Germany and Russia have framed the conditions for these gaps to enable gentrification. The Commodification Gap is an indispensable resource for researchers and academics studying human geography, housing studies, urban sociology and spatial planning.

Matthias Bernt is a sociologist and political scientist who works as a Senior Researcher at the Leibniz Institute for Research on Society and Space in Erkner, Germany. Andrej Holm is a Senior Researcher and Lecturer of Urban Sociology at the Humboldt-University Berlin. Paul Watt is professor in Urban Studies at Birkbeck College, University of London.

The numerous military conflicts that have been taking place in the recent years in the Middle East and Africa, Turkey and most recently in Ukraine caused a situation of mass forced migration from these regions to Europe. Scholars at risk formed a part of these recent migration flows. On the one hand, the European academic community has got a chance to demonstrate its professional solidarity to these people. On the other hand, European countries and academia in particular have got access to a high-quality human capital of academics, who were displaced from their countries. However, we do not know how it worked in reality, whether integration of scholars at risk was successful, and what troubles and challenges they have been facing. Therefore, we would like to bring together Turkish, Ukrainian, Russian and Belarusian scholars at risk who have left their countries in recent years, and to discuss their experience of being scholars at risk in Europe.



The Research Network Urban Sociology aims to stimulate scientific debate within the area of Urban Sociology, by creating a cross-disciplinary space of exchange open to sociologists and scientists from other disciplines interested in creating knowledge about, but also intervening in, urban space and urban life. The Research Network started in Turin in 2013 as a Research Stream on Urban Sociology and Public Spaces

The network was formally constituted the next year and a first Midterm conference, with the theme Public Spaces, Private Lives, was organized in November 2014 in Lisbon, with Kirsteen Paton and Ray Hutchinson as keynote speakers. In Prague, the next year, the first Coordination and Board were elected and we had very interesting sessions. In 2016, our second midterm conference took place in

Krakow, where we welcomed around 170 urban researchers, including keynote speakers Saskia Sassen, Talja Blokland, Ayo Mansaray and Jacek Gądecki. With carefully selected contributions from the conference, the coordination and board published a book with Springer: Moving Cities – Contested Views on Urban Life

In our last Midterm Conference in Madrid (June 2018), we had two very interesting keynote lectures by Jesus Leal and Susanne Hall and many interesting sessions around the main theme: "Inequality and uncertainty: current challenges for cities".






