### **Dissertation Project:**

'Sweet Science': Tender Empiricism, Mortal Materialism, and Romantic Form

This dissertation in comparative romanticisms and the history of biomedical science concerns crossings between pre-Darwinian biology, romantic poetics, and historical critique in the decades surrounding the French Revolution. From Diderot to Herder, Erasmus Darwin, Percy Shelley and Marx, it traces attempts at what Goethe named "zarte Empirie" and Blake "sweet Science": poetic physiologies and physiological poetics that sought to revise the scene of empirical observation and contest the then-deepening distinction between objective and imaginative knowledge. The project re-mobilizes historically-available alternatives to the idealist conceptions of life, matter, and figure that have dominated the twentieth century reception and deconstruction of romantic aesthetics, inhabiting various hylozoist positions and investigating the romantic afterlife of Lucretian figural materialism. Its genre-bending texts of choice strain poetic and empirical protocols to address the social relations surrounding selves and things, the untidy likelihood that experiment transforms both observer and observed, the continuity between somatic and cognitive interchange, and the evidence that bodies in timewhether textual, animal, or political—are sculpted by losses, impacts, and incorporations of what is not self and not immediately present.
